## Customer Hire Agreement

### Hire periods

The full hire period is the dates shown on the hire contract. At the end of the full hire period, goods not made available for collection will be placed back on hire for a further hire, Period and at the same hire charge. You must pay us the extra charges when we ask for Those, to include any additional costs incurred. The contract comes into effect when you have Signed and agreed to keep to these conditions of the contract and we have accepted your order.

### You the hirer are responsible for:-

- You must assist us with delivery and collection, and insure your location is safe for us to work in. we accept no responsibility for injury caused. The hirer will supply electricity and water no further than 15m away from the hot tub.
- The hirer will inspect equipment and make note of any damage.
- Never sit on the cover. Or stand on the housing.
- At a temperature of 37° or above never spend more than 15 minutes in the hot tub.
- No one under the age of 6 years old to enter the hot tub.
- No jumping in or on the tub. No diving.
- Supervise children under 16 years of age.
- Add chemicals as understood by you and instructed by intex, layz spa, mspa, Happytubs
- The hirer will not tamper or adjust any aspect of the equipment mechanics or electrics. You will be responsible for any death, injury, loss or damage caused by the goods being misused while they are hired.

### Steps to take before using the hot tub

- Enter the water with care. Test first
- Shower before using the hot tub.
- Remove make up, fake tan, sun tan lotion. **Not doing this will damage the pump also blocking the filtration.**
- Only wear swim wear. Not jeans, shoes etc.
- Never use bottles, glasses only plastic cups.
- Insure the filter is fitted to the bottom most inlet. And cleaned when needed.

### Cleaning up

- Clean all equipment after use. Empty the hot tub. £50 cleaning charge will apply if hired equipment is not handed back clean.

- Never sell. Move or give up control of the equipment.
- Insure no one uses the spa with unhealthy water. And they have permission from there doctor.
- No one is under the influence of drugs or alcohol.
- No more than 6 adults at any one time.
- Insure the cover is on when not in use.
- Insure the heater is on during hire.
- Call outs are £50 due to misuse.
- You agree for happytubs to gain access for collection of hired equipment.
- No smoking in or around any hired equipment.

### Hire of Gazebos

- Adjust anchor straps during strong winds. Remove curtains in extreme winds. Call happytubs for advice during poor weather.
- Supervise male dogs so not to allow them to urinate on any hired equipment. Cleaning charge of £50 will apply.
